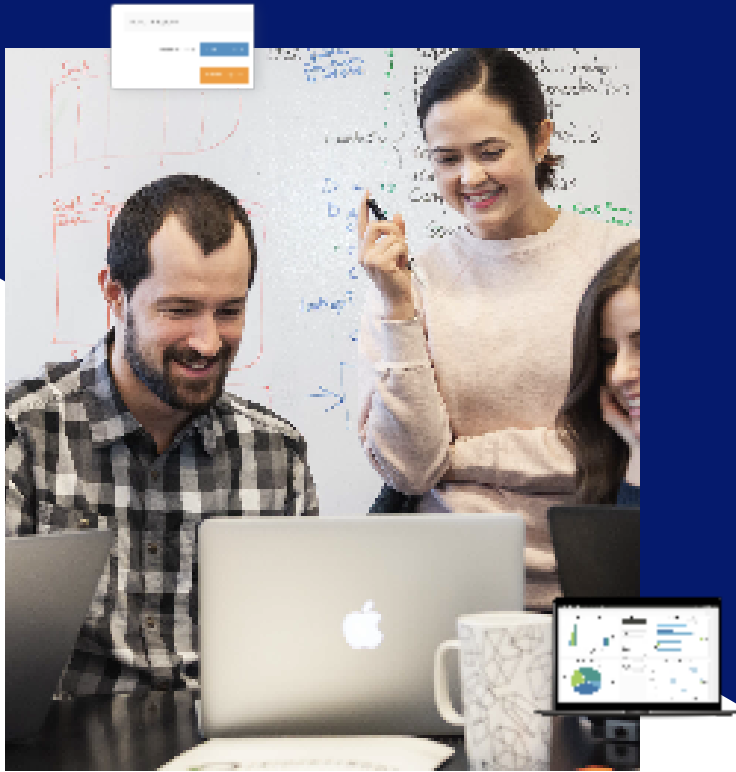
## CHALLENGE
